
ROCC Business Meeting March 11, 2018 Ridgway Community Center

Currently ROCC has 230 members (145 memberships).

ROCC Talks – Kate Kellogg

In October we will have a talk on the Future of Ouray County, possibly with a panel discussion including people from Town of Ridgway, City of Ouray and Ouray County.

Clean Energy – Rein van West

Sixty three percent of Tri-States energy comes from coal. And because of Tri-State's 5 percent renewable energy production limits SMPA can't build another solar farm to service its members at this time. However, the energy produced from residential solar systems isn't subject to the 5 percent limit so we should be encouraging people to install residential solar systems in Ouray County.

Public Lands – Robyn Cascade

1. GMUG Forest Plan

Report of ROCC Social Justice Committee for ROCC General Meeting March 11, 2018

Over the past couple of months we have been trying to keep affordable housing in the forefront of agendas of OCHAC. OCHAC gave us the go ahead to take a letter to the BOCC, Town of Ridgway and Ouray City Council. There are three things we are asking these 3 entities to consider:

- 1. A uniform percentage of new developments be designated deed restricted.
- 2. Uniform time limits for deed restrictions with a view towards extending those into perpetuity.
- 3. Asking the City, Town and County to develop a plan providing incentives to businesses to develop housing plans for their employees.

This will be happening very soon.

One idea that has been floating around in different places is amending Tabor and bringing back the transfer fee to be used for affordable housing. Telluride was grandfathered in on the Transfer fee and they bring in quite a bit of money for affordable housing.

The SJ Committee also looked at being part of the Rapid Response Team also known as Corrn, (Colorado Rapid Response Network.) Trained people respond when there is an ICE raid happening. We have three and maybe a fourth person interested in taking the training. We would volunteer in Ouray County.

There are three positions: Dispatcher (person has to speak Spanish also) Confirmer, (person who records what happens, and that it is an ICE raid and not some other group like SWAT) and a Legal Observer who takes photographs, etc.)

We have a couple of requests for the ROCC group to consider. We recently found out that HAP and CIRC are losing their office space. The building was sold and bought by the Center for Mental Health. They have to be out in two months. HAP and CIRC share office space. They are working to find a new place. Our request is that ROCC consider being a member of CIRC just like WCC is. They only take businesses and organization members. It would be a good way for us to support them. Karen Perez said that they have 5 member groups throughout the state and all of them need more members. These groups are a coalition of people from various businesses and organization. These groups give CIRC power to engage the community. It strengthens them to do the work they have to do. There are so many threats against the immigrant communities. Karen would be very thankful if you would consider becoming a member.

Second: HAP doesn't have a lot of operating money to work with. They get donations but can always use more. We would like to send out an appeal to the ROCC organization for individual donations to HAP. This could easily go out in the "What ROCCs" email.

Then anyone who wants can donate to this worthy organization. HAP does amazing work in our local communities.

Our third and final request is a ROCC membership list. We would like to see if we can get a membership list of the larger ROCC group. If not that than at least a list of who is on the different committees and phone numbers for that.

Kathy and Tom Heffernan, Co-chairs of SJ Committee

Grants – Scott Williams

Scott noted that Robyn's leadership money is not technically a grant, but money for leadership training.

The committee approved a \$500 music sponsorship for UWP's annual River Fest in June.

WCA – Don Swartz

Don outlined ROCC's Board's response to several requests made by WCA to ROCC. Namely, the Board was in favor of WCC changing its name to WCA (Western Colorado Alliance), but the Board was not in favor of changing ROCC's name to WCA – Ouray County.

New Business:

1. Partners Program – Levy Krey

Krey works for both the Partners Program and the Voyager Youth Program. Partners is a program that matches adult mentors with children in Delta, Montrose and Ouray Counties. They work with children ages 6 to 17, and it has about 40 children in the program. Mentors are asked to work with the child they are assigned for three hours each week.

Partners needs volunteer mentors who are willing to enter into longterm commitments.

Each year Partners has a volunteer dinner and an online auction fundraising event. Jen and Randy Parker and Vicki Huggins are mentors in this program. So, they can answer any questions that potential volunteer mentors may have.

2. Dark Skies Certification for the Town of Ridgway – Valentine Szarc and Dave Jones

Val and Dave are seeking to get the Town of Ridgway a Dark Sky Designation by the International Dark Sky Association. Thirty-seven places already have this designation including Westcliffe, Colorado and Torrey, Utah.

Val believes that Ridgway is an excellent candidate for the IDA Dark Sky Community Designation, since Ridgway already meets a number of the prerequisites for this designation. And they would like to take this issue to the Ridgway Town Council at its next meeting in April.

Val and Dave are asking ROCC to set up an exploratory committee on this issue and have the committee report back to the ROCC Board in two months.

Scott Williams made a motion that ROCC set up a working committee to work on this issue. Rein van West seconded the motion. After some discussion the motion passed.

Introduction – and Why We Are Here

- The Dark Sky is a Natural Resource that is slipping away
 - Just like the clean air we breath and the clean water we drink
 - Southwestern Colorado has one of the last dark skies in the US – and it desires our efforts for preservation
- We are here to ask for ROCC's continuing support in preserving the night sky over Ridgway
 - Preservation of the Dark Sky Resource compliments ROCC's mission
 - Take the next step to be <u>formally</u> recognized by the International Dark Sky Association (IDA)

Background – past dark sky efforts

- 1994 ROCC designates Dark Sky
 Preservation as one of it's main missions
- ROCC members spearheaded dark sky lighting ordinances in Ridgway and Ouray County
- Major revitalization of historic downtown Ridgway includes full cutoff decorative fixtures with "warm" (3000K) LED lamps
 - Fully IDA compliant

Benefits and The International Dark Sky Association Mission

- The <u>IDA</u> have designated <u>37 places</u> around the world that recognize and promote excellent stewardship of the night sky through responsible lighting and public education
 - Westcliffe Colorado and Torrey Utah
 - Ridgway is a perfect candidate
- Maintains our natural resource and the starry sky as can be seen over the dark skies of Western Colorado and the Western US
- Energy conservation though smart efficient use of lighting
- Helps minimize impacts to wildlife and migrations

The IDA criteria and process for a successful designation

- IDA designates Dark Sky Places following a defined application process
 - Demonstrate robust community support for dark sky protection
 - Document Dark Sky designation-specific program requirements.
 - Town lighting updates to local ordinances as needed
 - Validation of dark sky resource via measurements
 - Public education
 - Support letters from public, business, and local Gov

Ridgway's potential for success


- Preliminary Assessment
 - Initial sky darkness measurements are positive
 - Town of Ridgway owned LED street lights are IDA compliant
 - Ridgway Lightning Ordinance
 - · Many IDA requirements are present
 - · Some updates however will be needed
 - LED color temperature, Lumens, policy statements, etc
- Ridgway appears to be an excellent candidate for IDA Dark Sky Community Designation!

Preliminary Next Steps

- Request ROCC set up an exploratory committee and a request for volunteers to focus on assessment of possible pursuit of Dark Sky Designation by IDA for Ridgway
 - Objective of assessing potential effort, timeline, resources, community support, and funding (if needed)
 - Determine Ridgway Town Council willingness for lighting ordinance enhancements
 - To be fully IDA compliant
 - Led by Val Szwarc and Dave Jones
 - Report back to ROCC in 2(TBR) months with mature assessment results and recommendations
